This Privacy Policy explains how STARLINE Driving School ("Company", "we", "us") collects, uses, protects, and discloses information when you use STARLINEDRIVINGSCHOOL.COM ("Website").
By using the Website, you consent to this Policy.

1. Information We Collect

We collect:

A. Personal Information

- Name
- Address
- Phone number
- Email
- Date of birth
- Driver's license or learner's permit number
- Payment information (processed by third parties)

B. Automatically Collected Data

- IP address
- Browser type
- Device information
- Cookies and analytics data

C. Student Records

For scheduling, attendance, progress tracking, and compliance with FLHSMV requirements.



2. How We Use Your Information

We use your information to:

- Provide training and schedule lessons
- Process payments
- Maintain student records
- Comply with state regulations
- Improve our services
- Communicate updates and notifications

3. Sharing of Information

We may share data only with:

- FLHSMV (when required by law)
- Payment processors
- Service providers for scheduling or communication
- Law enforcement, when legally required

We do not sell personal information.

4. Minors & COPPA Compliance

We do not knowingly collect information from children under 13. For teenagers (14–17), parental consent may be required depending on the service.

5. Data Retention

We retain personal and student records only as long as necessary to comply with:

- Florida Statutes Chapter 488
- FLHSMV auditing requirements
- Federal DPPA (Driver Privacy Protection Act)

6. Data Security

We use encryption, secure servers, and authenticated access. No online system is perfectly secure, but we follow industry standards.



7. Cookies

We use cookies for analytics and performance. Users may disable cookies in their browser settings.

8. Your Rights

You may request:

- Access to your data
- Correction of incorrect information
- Deletion of your data (unless legally retained)
